
Participation:

Outline

The training event is a spin-off of the IPA project implementation manual in force as of integral part of the Management and Control System documents of the INTERREG IPA CBC Greece – Republic of North Macedonia 2014-2020 Programme.

Initially, two training sessions for all the IPA project beneficiaries of the 1st CfPPs and for the FLC Controllers and the JS and Antenna officers of the ETCPs in the country were conducted with 100% of the sessions online on the dates 25 and 26 of January 2021. The beneficiaries were guided through the application platform which was simply for usage and also was answered to specific issues related to accessibility way, the users' password to access the application platform settings and other queries.

The extra session of face-to-face training was conducted solely for the NA's designated Operating structure on 27 January 2021. The training was delivered to each staff individually at the premises of the Ministry of Local Self Government.

Objective of the training seminar

This seminar aims at developing the participant's skills for the online application in the Information e-platform, as well as their upgrading knowledge and understanding of how to apply the system, including e-tools usage. This event will focus on the following topics: submission of the IPA Beneficiary's Requests for pre-financing and national co-financing agreement, Requests for designation of the FLC Controllers, Management verification process, Requests for national co-financing payments, including also the e-tool for irregularities alerts that is accessible for all citizens to report.

We will discuss also what have been the experiences and best practices in the times of pandemic (discussion with participants about the challenges with IPA beneficiaries of the 1st call projects that across Info module we relieved their access online whilst they submitted the requests to the National Operating Structure within the Ministry of Local Self Government. and other topics that would help increase the quality of performance and to smooth implementation of the projet activities within the INTERREG IPA CBC Greece- Republic of North Macedonia 2014-2020 Programme.

Format of the seminar

National Authority in cooperation with the Managing Authority of the Programme and the Joint Secretariat will facilitate this hybrid training seminar expecting contributions in the form of active participation of all IPA beneficiaries and FLC controllers in discussions about the practices used through the Info module (online system applicative) which increases the quality of administrative processes and services provided by the Ministry of Local Self-Government. Joint training on facilitation will add to ways of working across beneficiaries, where cooperation between the National Authority and IPA beneficiaries from various project locations is essential. Ultimately, this should lead to improved quality of the National Authority's support and assistance to IPA beneficiaries in the country.

The training session is dedicated to all the IPA beneficiaries 2nd call projects and of 3rd call restricted project in the country and to extra FLC Controllers appointed by the MLSG and to National Operating structure staff.
